

" Process for Registering for UAE Corporate Tax"



Doing business in the UAE or having an entity there! Don't forget to register for corporate tax. Failure to submit the registration application on time can result in a penalty of AED 10,000.

- 1. Create an account on Emara tax portal, if not already done. https://eservices.tax.gov.ae/#/Logon
- 2. Choose a type of user Select a taxable person category.
- 3. Create a New Taxable Person Profile (Mention the name of your company), uploading logo is optional.
- 4. Click view on the Taxable Person Profile and check the registration overview. It will have Corporate Tax, Value Added Tax, Tax Group, Excise Tax, Warehouse Keeper.

5. Click on right corner in the Corporate Tax row and then click "Register"
